

**EXTENSION OF PROVISIONAL CLEARANCE FOR CURRENT RELAY PART NO.
IR88CIR 4.5/9A FOR USE ON JAGUAR AIRCRAFT.**

1. Current Relay Pt. No. IR88CIR 4.5/9A was provisionally cleared for use on Jaguar aircraft vide RCMA (A/C)/HAL (BC)/330 dated 02 Jul 2012 and extended for one year vide even ref No. dated 14 Aug 2013.
2. HAL vide A/CM(DL)/IDE/50/15 dated 14 Feb 2015 intimated that there was production hold up due to unforeseen reason at the production facility. At present, HAL Purchase Order for the subject relay (66 nos) is pending with the vendor. As the item has not been supplied, performance feedback is not available.
3. In view of the above, Provisional Clearance issued is hereby extended for a period of one year during which the vendor / HAL should obtain the feedback on the performance and take up for Type Approval.
4. All other conditions stipulated in the provisional clearance issued remain same.
